**COURSE PROVISIONS**

Frankenmuth Driving School will provide a minimum of 6 hours of classroom instruction by a certified instructor. Classroom instruction will not exceed 2 hours per day.

**TERMS**

1. The student, parent, or guardian agrees to remit \$70 payable by cash, check or money order to Frankenmuth Driving School.
2. The student must provide a Level 1 License and driving log signed by a parent or guardian to verify eligibility for the course (see "Required Language" below).
3. The student must satisfactorily complete all classroom assignments. A minimum score of 70% must be achieved on the final test. Up to two retakes are allowed.
4. The student must attend all three class periods. No make-ups are offered.

**REQUIRED LANGUAGE**

NOTICE – this driver education provider is required to be certified by the Secretary of State. Completing driver education does not guarantee a driver's license.

**A minimum of 30 hours of supervised driving, including two hours of nighttime driving, on a Level 1 license that has been held for at least three continuous months must be completed before a student can be accepted into Segment Two. Supervised driving is defined as driving with a licensed parent, guardian, or parent designee age 21 or older.**

**REFUND POLICY**

If for any reason the student withdraws from the course before its completion, any refund will be based upon the following:

- a. The student is eligible for a full refund if Frankenmuth Driving School is notified of the decision to withdraw prior to the first class
- b. No refunds will be given after the first class
- c. Extenuating circumstances will be reviewed on an individual basis
